#### 1. Established in 2018

### Our Financial Position

We are in a good financial position



2019 - Property acquired on the strength of 168K in Namadhenu



\$220K in BNZ Term Deposits this year and now we have total of 480K in Term Deposits.



2020 - Powered by another 68K with Namas, we reached an Equity of over 300K



Our financial performance remains as last year i.e. 136K surplus for this year.



2021 - With continued Namas (\$55k) and all round activity, we have grown our equity to over \$400K




Our total equity is a little over 715K by year ending June 2023.

Our plan in the next 2 years is to consolidate financially and consult the community on the future Temple Build.


























































### Financial Reflection





#### **Year 2023**

Shows a reduction in General Donations and Pooja related donations – indicating that our devotees are feeling the pinch of high inflation and interest rates. The economic downturn is expected to continue.



#### **Fundraising & Term Deposits Interest**

Higher Fundraising and Interest from Term Deposits helped us get through a difficult year



#### **Public Equity**

Public Equity in Temple is \$715k at Book Value and over \$1m if we consider the fair value of the property.



#### **Hundi Collections**

Hundi collection is steady indicating that devotee numbers are holding out.



#### **Financial Progress**

Overall, we have grown our Bank Funds by \$150k annually over the last three years – indicating a solid patronage.
